



LICENSE AGREEMENT

E x H, Inc. and its Affiliates (“E x H”)

End User License Agreement for the following licensed software:

- **E x H reTORT Ray Tracer, All Versions**
- **GEMSIF (GEometry, Modeling, and Simulation InterFace), a unified GUI, All Versions**
- **reTORT and GEMSIF being the Software, per the Definitions below.**
- **PFSS (Periodic Frequency-Selective Surfaces), All Versions**
- **DGTD (Discontinuous Galerkin Time Domain), All Versions**

1. Definitions.

- a. “Affiliate” of a company means any person or other entity directly or indirectly controlling, controlled by, or under common control of such company.
- b. “Commercial License” means a License which may be used in for-profit and commercial activities. A Commercial License may also be used in non-commercial activities but a Non-Commercial License, such as an Education License, may not be used in for-profit or commercial activities.
- c. “Computer” means either (i) a single physical hardware system containing a single motherboard running an operating system, or (ii) a virtual machine running an operating system.
- d. “DGTD” means Discontinuous Galerkin Time Domain, is an E x H solver, and is a simulation tool used to rapidly and efficiently solve the problem of electromagnetic scattering from meshed 3D structures for any incidence angle or polarization. The software is suitable for designing devices for RF, optical, terahertz, UV, and infrared applications. DGTD will only run through GEMSIF and cannot be used as a standalone tool.
- e. “Documentation” means the user guides, articles, FAQs and Knowledge Base, if any, accompanying delivery of the Software, as may be updated from time to time, including any bug reports which E x H may make available from time to time. Documentation may be delivered in any medium or language.
- f. “Education License” means a License which may purely be used for Educational Purposes that are also non-commercial, not for-profit purposes.
- g. “Effective Date of Program(s)” means the date specified in the License Key unless otherwise indicated on the License Form for the applicable Software.
- h. “GEMSIF”, a component of the Software (GEometry, Modeling, and Simulation InterFace), provides a unified GUI, data and file management system, and comprehensive scripting interface for all simulation tools. Each simulation tool builds upon GEMSIF by adding its functionality and capability to GEMSIF, enabling users to select the proper solver for a given problem



- without opening multiple programs. Access to any simulation tool is only through GEMSIF.
- i. “License Key” means a software licensing management and security tool or other device that Licensor uses to allow Licensee access to the Software and which may have an expiration date. A License Key is locked to use on one host by matching a signature derived from the host to the signature assigned to the License Key.
 - j. “License Manager” means software, not licensed to Licensee, used to define the type of license, allowable uses, provide validation, and terminate licenses that are found to be invalid or whose license agreements are in breach.
 - k. “License Term” means the period of time during which Licensee is authorized to use Software in accordance with the applicable license grant.
 - l. “License” means a subscription license of GEMSIF plus one or more solvers. A Subscription License provides Licensee with the right to use the Software and receive offered upgrades for the period of Licensee’s subscription. At the end of Licensee’s subscription, the Software will be disabled unless Licensee purchase a new subscription.
 - m. “Licensee” means the entity who purchases an E x H license, including Licensee’s Affiliates.
 - n. “Licensor”, if used, is equivalent to E x H, its Affiliates, its Third Party Licensors and Partners.
 - o. “PFSS”, (Periodic Frequency-Selective Surfaces) is an E x H solver and is a simulation tool used to rapidly and efficiently solve the problem of electromagnetic scattering from periodic, 2.5D structures for any incidence angle or polarization. PFSS will only run through GEMSIF and cannot be used as a standalone tool.
 - p. “PSRF” means the Penn State Research Foundation.
 - q. “PSU” means The Pennsylvania State University.
 - r. “reTORT” is an E x H solver and is a geometric-optics ray tracer for modeling and optimizing complex optical systems that may include arbitrary three-dimensional refractive index gradients. reTORT will only run through GEMSIF and cannot be used as a standalone tool.
 - s. “Software” means the licensed software, the license key required to access the software, and other materials accompanying the License and the software together with all corresponding Documentation, whether accompanying the programs or available online.
 - t. “Third Party” means any person or legal entity that is not Licensor, Licensee or an Affiliate of either Licensor or Licensee.
 - u. “Third Party Software” means the software referenced in Section 7 of this Agreement.
 - v. “Trial License” means a functional copy of the Software, licensed for a limited period of time, not for use in commercial activities, nor any for-profit activities,



but purely for the purpose of evaluation of the purchase of a commercial license by the Licensee.

2. NOTICE:

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT ("License") CAREFULLY BEFORE ACCESSING OR USING THE SOFTWARE. THIS IS AN AGREEMENT BETWEEN LICENSEE AND E X H. BY COPYING, INSTALLING OR USING THE SOFTWARE OR THE DOCUMENTATION, LICENSEE IS AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT COPY, INSTALL OR USE THE SOFTWARE OR THE DOCUMENTATION.

THE LICENSE AGREEMENT TOGETHER WITH ANY ATTACHMENTS AND EXHIBITS REPRESENTS THE ENTIRE AGREEMENT BETWEEN LICENSEE AND E x H CONCERNING THE ALLOWABLE USES AND RESTRICTED USES OF THE SOFTWARE BY LICENSEE.

THE SOFTWARE, ONCE LICENSED, IS NON-REFUNDABLE.

3. General.

The software, its documentation, the license key required to access the software, and other materials accompanying the License (taken all together, the "Software"), whether on disk, print or electronic documentation, in read only memory, or any other media are licensed, not sold, to Licensee by E x H. The rights granted herein are limited to E x H's intellectual property rights in the Software and do not include any other patents or intellectual property rights. E x H Software is licensed and not sold. Licensee own the media on which the Software is installed but E x H retains ownership of the Software itself and the license key(s) provided to Licensee to access the software per this License Agreement. The terms of this License will govern any Software updates provided by E x H that replace, modify, and/or supplement the original Software, unless such update is accompanied by a separate license in which case the terms of that license will govern.

4. Master License Grant. Permitted License Uses and Restrictions.

Subject to the terms of this License, E x H hereby grants to Licensee, and Licensee hereby accepts, a non-exclusive (E x H may license to others), non-transferable (Licensee may not transfer this license to another person or entity without E x H's permission), non-sublicensable (Licensee may not resell or license this Software to others), limited-scope (Licensee's license is for a specific Software version, for the License Term, and/or subject to other terms or restrictions), license to use the Software provided to Licensee by E x H, solely for the purposes for which E x H intended the Software to be used, as defined by the documentation and the Software's User Interface. Licensee may install and use the Software solely on Computers controlled by Licensee.



Licensee may provide access to online Documentation on Licensee's intranet, provided it is not accessible over the open Internet.

This is a single user License. For each license key issued to Licensee upon purchase of a valid License, Licensee may install one copy of the Software on one computer

If this is a Trial License as defined above, Permitted Uses are for non-commercial, not for-profit purposes. Licensee agrees not to use the software in for-profit activities and that the purpose of the Trial License is purely for Licensee's evaluation with the intent to purchase a commercial license.

If this is an Education License, as defined above, Permitted Uses are purely for Educational Purposes that are also non-commercial, not for-profit purposes.

E x H may issue updates or upgrades from time to time which it may offer to Licensee depending on the type and status of Licensee's License. However, there is no guarantee that any such updates or upgrades will be issued during the Effective period of Licensee's License.

5. License Restrictions and Permitted Uses.

Licensee may not copy, decompile, reverse engineer, disassemble, attempt to derive the source code of the Software, modify, decrypt, create derivative works of, sublicense, resell, or otherwise redistribute the Software, or use the Software in any other manner or for any other purpose not expressly and explicitly granted to Licensee by E x H in this Agreement.

Licensee may not use the Software or any part of the Software, for any act which infringes copyright of the Software including developing, producing, or testing a computer program containing a feature or functionality that is substantially similar in its expression to the expression contained in the Software or any part of the Software.

Licensee may not adapt, translate, copy, or convert all or any part of the Software in order to create software, a principal purpose of which is to perform the same or similar functions to the Software or to replace the Software or any component of the Software.

Licensee may not rent, lease, or loan the Software; use the Software for supporting Third Parties' use of the Software, time share the Software, or provide service bureau or similar service use.

Licensee may not attempt to gain access to the Software's method of operation or source code in any manner for any purpose.

Licensee may not provide access, publish, display, distribute, disseminate, assign, or



otherwise transfer (whether by sale, exchange, lease, gift, or otherwise) to a Third Party the Software, any copy or portion thereof, or any License or other rights thereto, in whole or in part, without the prior written consent of E x H.

Licensee may not provide access (directly or indirectly) to the Software via a web or network Application.

Licensee may not copy, make available for copy, or otherwise reproduce the Programs, in whole or in part, except solely for back-up purposes provided that any such permitted copies shall reproduce all copyright, patent, logo, proprietary and/or other legal notices contained in the original copy obtained from E x H.

Licensee may not in any way display or communicate Software as its own property. If Software is mentioned publicly, E x H shall be credited as the owner and creator, for example, as in, "... reTORT, a Geometric Optics Ray Tracer computational product from E x H, Inc."

Licensee agrees that if Licensee is found to be in violation of this License, without liability to E x H or compensation to Licensee, E x H may disable the Software, void Licensee's license, or take other measures to prevent further use of the Software. E x H may take any other measures which are available to it under the Law, without notice or compensation to Licensee.

Should a License Key be found to be in use on multiple computers, or should a License Key be found in the public domain, E x H shall have the right to mark this License Key as an Invalid License Key and to disable the Software on all computers using any Invalid License Key, without notice or compensation due to any user.

6. Licenses for Third Party Software.

Licensor has been granted licenses to distribute certain Third Party Software as part of or included with the Programs licensed. These licenses require Licensor to distribute the software to Licensee subject to specific terms and conditions. In the case of proprietary Third Party Software, Licensor manages these terms within the scope of Licensor's License and Licensee's restrictions are identical to those found in this Agreement. In the case of Third Party Software subject to the Lesser General Public License, Licensee may make modifications of the work identified in Section 6 of the Lesser General Public License for Licensee's own use and reverse engineering for debugging such modifications. Third Party Lesser General Public Licenses included herein are listed in documentation accompanying the Software and links to the License information.

7. Support Services.

License is by Subscription only. During the License Term, E x H will make available subsequent releases of the Licensed Software, if any, and make reasonable efforts to both (a) provide, within a reasonable time, workarounds for any material programming



errors in the current release of the Software that are directly attributable to E x H, (b) push such bug fixes in the next available release, provided Licensee provides E x H with sufficient information to identify the errors, and (c) provide online and email technical support. E x H reserves the option to discontinue Support Services to any Licensee whom it reasonably believes is in breach of this Agreement.

8. Validation.

The Software may connect to the E x H server from time to time, at intervals determined by E x H, for purposes of determining whether the Software is properly licensed in accordance with this License Agreement. If the Software is found not to be in accordance with the License Agreement, it will be marked invalid and the Software disabled. Licensee, agrees to E x H's access to the License Key, other code installed by E x H on Licensee's computer system for purposes of licensing and license validation, and to other information, as described in E x H's privacy policy, that is helpful to E x H in servicing Licensee.

9. Termination.

The license granted herein will continue in force until expiration of the License Term or until otherwise terminated. If Licensee fails to pay any monies or provide any services due in connection with the Software, or violates any term or condition of this License Agreement (equally "License"), this License is considered immediately terminated. If Licensee, violates any condition of this License Agreement, E x H is not required to give notice of termination to Licensee, and notwithstanding, the License Agreement is considered to be terminated at the moment of said violation or violations with no compensation due Licensee. No notice of termination shall be required by E x H but, at its option, E x H may choose to notify Licensee of Termination if Licensee has provided contact information to E x H, or, E x H may choose to generate an automatic or online message via the Software or via connection to the E x H server. Should Licensee find his license terminated and the Software disabled and believe they did not violate the License Agreement, they may contact support@exhsw.com. Otherwise, the correct course of action is to purchase a valid license. Licensee also may terminate this License voluntarily by giving notice of termination to E x H and destroying or returning to E x H all copies of all or any part of the Software and related user documentation in Licensee's possession or under Licensee's control. In such case, no compensation shall be due Licensee. E x H has the right to discontinue the Software or any specific version of the Software, or to discontinue support for the Software or any specific version of the Software at any time, without notice to the Licensee. Termination for any reason will be without liability to E x H or compensation to Licensee.

10. Confidentiality

Licensee will take all reasonable steps to ensure that the Software and any other material or information, including license keys, herein identified by E x H to be confidential ("Confidential Information"), is kept confidential and disclosed only to valid users who



have purchased a License. Confidential Information will not be disclosed to others, in whole or in part, without the prior written permission of E x H. Licensee will immediately return or destroy any or all Confidential Information that has been provided to it by E x H, upon E x H's request, or upon Termination of this License.

11. Taxes, Duties, Customs.

Absent appropriate exemption certificates or other conclusive proof of tax exempt status, Licensee shall pay all applicable sales, use, excise, value-added, and other taxes, duties, levies, assessments, and governmental charges payable in connection with this Agreement or the Licenses granted hereunder, excluding taxes based on or measured by E x H's income, for which E x H shall be solely responsible.

12. Assignment.

Licensee may not assign or otherwise transfer this Agreement and any License hereunder, by operation of law or otherwise, without the written consent of E x H. Licensee agrees that E x H may withhold such consent if it determines, in its sole discretion, that a principal purpose of the acquisition of this License was to assign the License to a Third Party. In the case of any permitted or other lawful assignment or transfer, the terms of this Agreement, including any License hereunder, shall be binding upon, and inure to the benefit of, the transferee or assignee. E x H may charge Licensee an administrative fee for any permitted assignment.

13. Disclaimer of Warranties.

THE SOFTWARE, ITS DOCUMENTATION, AND ANY SERVICES PROVIDED HEREUNDER OR IN CONNECTION WITH THIS LICENSE AGREEMENT, OR OTHERWISE SUPPLIED IN CONNECTION WITH THE SOFTWARE, ARE PROVIDED "AS-IS". 16. Export Control.

Licensee may not use or otherwise export or re-export the Software except as authorized by United States law and the laws of the jurisdiction(s) in which the Software was obtained. In particular, but without limitation, the Software may not be exported or re-exported (a) into any U.S. embargoed countries (<https://www.bis.doc.gov/index.php/policy-guidance/country-guidance/sanctioned-destinations>) or (b) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals (<https://www.treasury.gov/resource-center/sanctions/sdn-list/pages/default.aspx>) or the U.S. Department of Commerce Denied Person's List or Entity List (<https://www.bis.doc.gov/index.php/policy-guidance/lists-of-parties-of-concern>). 18. Controlling Law and Severability.

This License will be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania, in the same manner as would be applied to agreements entered into and to be performed entirely within Pennsylvania between Pennsylvania residents. Licensee and Licensor hereby waive any right to trial by jury or to claim or be awarded any consequential, special, exemplary, or punitive damages. Licensee agrees to be subject to the jurisdiction and venue of the state and federal courts serving Centre County, Pennsylvania. This License shall not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. If for any reason a court of competent jurisdiction finds any provision, or portion thereof, to be unenforceable, the remainder of this License shall continue in full force and effect.

19. Complete Agreement; Governing Language.

This License constitutes the entire agreement between the parties with respect to the use



of the Software licensed hereunder and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by E x H. Any translation of this Agreement is done for local requirements and in the event of a dispute between the English and any non-English version, the English version of this Agreement shall govern.

By installing the Software, you agree to the above License Terms. If you do not agree to the License Terms, do not proceed to install the Software.
